Financial Update

Lisa McCargar, Chief Financial Officer, provided a financial update of GSFA. Ms. McCargar reviewed the April 30, 2020 GSFA Balance Sheet. Additionally, Lisa noted that the entity has established a set of internal controls to ensure that GSFA's financial position remains strong.

Supervisor Griffith, Alpine County, stated that going forward, GSNR board nominees' background and experience in starting and/or operating businesses should be considered. It was agreed that this was an important consideration.

At the request of the Chair, Supervisor Kobseff, Siskiyou County, reviewed his business background consisting of 30+ years in the restaurant industry and formally expressed his desire to be considered for nomination as a GSNR Director.

GSFA Resolution 20-05: Authorizing Applications to the Federal Communications Commission for Rural Digital Opportunity Fund Support

Barbara Hayes, RCRC Chief Economic Development Officer, provided an overview of the Economic Development priorities for 2020, which includes rural broadband. Ms. Hayes discussed the significant lack of rural broadband in California and how the COVID-19 pandemic is further illuminating the significant disparities between those that have access to broadband and those that do not. After a review of national broadband programs, a model resulting in an open-access, public-benefit network that leverages public dollars with private investment and invites the participation of internet service providers, creating competition resulting in choice for rural residents and businesses has been identified. It is a model that is scalable, sustainable, and can be built with capacity for future technology applications.

Ms. Hayes described the opportunity presented by the Federal Communication Commission's Rural Digital Opportunity Fund (RDOF), a \$20+ billion program to support the development of broadband for "unserved" (service delivery of 25/3 or less) areas of the United States. This is a program that could be layered into the proposed program of work and potentially provide significant resources to serve the more remote, more expensive areas of RCRC's 37-member county area. The first step in competing for RDOF resources

is the submission of a Short Form application by July 15, 2020. The submission of a Short-Form application does not obligate an applicant to compete for RDOF funds, but without filing a Short Form application, the applicant is not qualified/permitted to compete for RDOF funds.

In response to questions from Supervisor Cann, Mr. Norton and Ms. Hayes clarified that the proposed action would approve submission only of the Short Form application by GSFA, and that further Board approval would be sought before participating in the RDOF auction.

Recommendation

It is recommended that the GSFA Board of Directors review and approve GSFA Resolution 20-05: Authorizing Applications to Federal Communications Commission for the Rural Development Opportunity Fund Support.

Self-Generation Incentive Program (SGIP) Bridge Financing Program

Craig Ferguson, Deputy Director, discussed the self-generation incentive program (SGIP). He noted that the impact of Public Safety Power Shut-off (PSPS) events on vulnerable populations in California is significant, and the California Public Utility Commission (CPUC) is working on mitigating those impacts. GSFA approached CPUC and CEC staff regarding a new use for the accumulated MIST funds as a bridge finance mechanism for residential ratepayers looking to participate in the SGIP. The goal of the proposed program is to provide short term "bridge" financing to qualified ratepayers to alleviate up-front funding constraints and allow more ratepayers to participate in the program.

Recommendation:

It is recommended that the GSFA Board of Directors take the following actions:

- Authorize GSFA to offer the SGIP bridge financing program as set forth in this memo.
- Authorize GSFA to utilize up to \$5MM of internal GSFA resources in a revolving fund to leverage the existing MIST funds and enhance the SGIP bridge financing program.
- Authorize the Executive Director or designee to establish SGIP bridge financing program terms and approve program contracts and implementing documents consistent with this memo.

GSFA Resolution 20-06: Authorizing the Implementation of a Revolving Loan Fund to Support Short Term Loans for Member Counties

Craig Ferguson discussed the common gap of funding affecting multiple member counties and the progression of their infrastructure projects. Mr. Ferguson explained in detail the grants awarded to these counties to fund these crucial projects. In many cases, the funding is received by the counties months after the project's completion. This project would allow GSFA to front these funds to member counties to complete their projects while they wait for the state and federal funding to be received.

Recommendation:

Approve GSFA Resolution 20-06, which would:

- Authorize GSFA to utilize up to \$3MM of internal GSFA resources in a revolving fund to develop a program to provide short term financing to member counties to help cover the upfront costs associated with the delay in obtaining grants or other forms of funding from the State or other agencies.
- Authorize the Executive Director or designee to establish loan financing program terms and approve program contracts and implementing documents consistent with this memo.

Program Updates

Craig Ferguson provided an update on the existing Housing and Energy Programs. GSFA has been busy with the Platinum Program during COVID-19. The interest-only program has seen increased activity in the past four months.

Economic Development Activity Update

Barbara Hayes provided an update on the CARES Act funding available through the California Housing and Community Development Department to non-entitlement jurisdictions. RCRC provided comment on the distribution of these dollars on a formulaic basis rather than competitively with the intent of establishing a smoother, faster process to get dollars to local governments. Ms. Hayes noted that applications need to be submitted by August 31st, 2020. If there are funds left over after that date, remaining funds will be awarded to those jurisdictions with previously approved applications. These funds are specifically for COVID-19 related activities.

Criteria for Public Projects in Member Counties - ACTION

Summary

On June 17, 2020, the Board of Directors approved Resolution 20-06 establishing a Revolving Loan Fund to support short term loans for member counties. The Resolution authorized GSFA to utilize up to \$3MM of internal GSFA resources in a revolving fund to develop a program to provide short term financing to member counties to help cover the upfront costs associated with the delay in obtaining grants or other forms of funding from the State or other agencies.

During rollout of the Revolving Loan Fund program, GSFA identified a need to expand eligibility to include selected short-term loans to public entities located within a GSFA member county (e.g., special districts and cities). This would include loans to public entities that have received grant funding for projects that broadly benefit member county residents, and would require a recommendation from a GSFA member county Supervisor. GSFA has also clarified that the grant funding source (from which GSFA's loan would be repaid) may include nongovernmental organizations, such as public utilities.

An updated Resolution confirming these revisions is presented for Board consideration. In the interim, the Executive Director has utilized his authority to implement business decisions, as provided during the annual budget process, to approve one such public entity loan in the amount of \$136,856 for installation of solar equipment by a Recreation and Parks District in a member county.

Recommendation:

It is recommended that the GSFA Board of Directors review and approve GSFA Resolution 20-08: Revising the Revolving Loan Fund Eligibility Criteria for Public Projects in Member Counties

RESOLUTION OF THE BOARD OF DIRECTORS OF THE GOLDEN STATE FINANCE AUTHORITY REVISING THE REVOLVING LOAN FUND ELIGIBILITY CRITERIA FOR PUBLIC PROJECTS IN MEMBER COUNTIES

WHEREAS, on June 17, 2020, the Board of Directors approved Resolution 20-06 establishing a Revolving Loan Fund to support short term loans for member counties; and

WHEREAS, it is desirable and appropriate to expand eligibility to include selected short-term loans to non-member public entities located within a GSFA member county; and

WHEREAS, making short-term loans to non-member public entities located within GSFA member counties is authorized by Government Code sections 6504, 6588, subdivision (j), and 26227, among other provisions of law.

NOW, THEREFORE, BE IT RESOLVED BY THE Board of the Authority as follows:

1. Section 1 of Resolution 20-06 is amended to read as follows:

GSFA is authorized to offer the revolving loan program to member counties and other public entities located within member counties as set forth in Resolutions 20-06 and 20-08 and the accompanying memos.

Summary

Each year, in conjunction with the adoption of the GSFA Annual Budget, the GSFA Executive Director is granted the authority to make necessary business decisions up to \$500,000 per decision outside of the approved operating budget, and to proceed with necessary operating decisions due to changes in the market, economy or changing transactional requirements to avoid unnecessary delay and provide the necessary flexibility to effectively and timely implement and modify programs. Such expenditures and operational decisions are to be made in consultation with the GSFA Deputy Director, the GSFA Chair and the GSFA Vice Chair and are to be reported back to the Board with subsequent ratification, as necessary.

Golden State Natural Resources

On March 11, 2020, GSFA and the Board discussed necessary expenditures to continue the Golden State Natural Resources (GSNR) project's progress with the GSFA Board in conjunction with a potential loan to GSNR per GSFA Resolution 20-03. Mr. Norton proposed to use this authority to expend up to \$500,000, in addition to the amounts previously included in the GSFA budget, to keep the project moving forward, and that a future loan from GSFA to GSNR would reimburse GSFA for expenditures up to \$500,000.

This memorandum provides a status through July 31, 2020 whereby approximately \$215,000 of the \$500,000 authority has been expended, including approximately \$200,000 to consultants for feasibility and other property studies. GSFA will continue to provide updates regarding expenditures and the progress of efforts. The GSNR Board will be meeting a number of times over the next couple of months moving forward to key actionable items.

Revolving Loan Fund

On June 17, 2020, the GSFA Board of Directors approved Resolution 20-06, Authorizing the Implementation of a Revolving Loan Fund to Support Short Term Loans for Member Counties. In addition, GSFA will, at the August 12th Board Meeting, present an amendment, Resolution 20-08: Revising the Revolving Loan Fund Eligibility Criteria for Public Projects in Member Counties. During the time between Resolution 20-06 and Resolution 20-07, GSFA and The Weed Recreation and Parks District entered into a Memorandum of Understanding regarding an advancement of funds for public purposes in the amount of \$136,856. Because Resolution 20-07 had not yet been approved by the GSFA Board, the Executive Director, under the provision and authority described above, authorized payment to the Weed Recreation and Parks District and is reporting the payment for this expenditure to the Board. This expenditure has been communicated to the GSFA Chair, Vice Chair and Deputy Director as required.

Broadband

On June 17, 2020, the GSFA authorized Resolution 20-05: Authorizing GSFA to file an application to the Federal Communications Commission for Rural Development Opportunity Fund Support. As a part of that application, GSFA engaged with Quadra Partners and Fiber Rise Communications LLP to assist with the application process. The fee for the initial application, not in the original GSFA budget, is \$50,000. The Executive Director, under the provision and authority described above, has authorized the payment of such expenditure and is reporting it to the GSFA Board of Directors. This expenditure has been communicated to the GSFA Chair, Vice Chair and Deputy Director as required.
